Eligibility to Vote

To be eligible to vote, you must be aged 18 years or more at the time of the Annual General Meeting (clause A3-3(3) of the Constitution).

New members to the credit union who joined less than 7 days before the Notice of Meeting was given are ineligible to vote at the Annual General Meeting on the matters described in the Notice of Meeting available at creditunionsa.com.au/agm and as set out in this Voting/ Proxy Form (clause A3-8(b) of the Constitution).

Each member is only entitled to one vote.*

Direct Vote

If eligible to vote, you may lodge a direct vote prior to the meeting by completing Part B of this Voting / Proxy Form. Alternatively, you can lodge your direct vote online. A valid direct vote cast by a member before a general meeting has the same effect as if the member had cast the vote in person at the meeting.

Appointment of Proxy

If you wish to appoint the Chair of the meeting as your proxy, mark \checkmark the box. If the individual or body corporate you wish to appoint as your proxy is someone other than the Chair of the meeting please write the full name of that individual or body corporate in the space provided. If you leave this section blank, or your named proxy does not attend the meeting, the Chair of the meeting will be your proxy. A proxy need not be a member of the Credit Union

Votes on Items of Business

You may direct your proxy how to vote by placing a mark ✓ in one of the boxes opposite the listed resolution. If you do not mark any of the boxes on the listed resolution, your proxy may vote on that resolution as he or she chooses. If you mark more than one box on a listed resolution your vote on the listed resolution will be invalid.

Signing Instructions

<u>Individual</u>: Where the membership is in one name, the member must sign.

<u>Joint Holding</u>: Where the membership is joint, the primary joint member must sign.

Attorney for Member: To sign under Power of Attorney, the Power of Attorney must be lodged with Credit Union SA Ltd. If you have not previously lodged it for notation, please attach a certified photocopy of the Power of Attorney to this form when you return it.

Company Member: A company member may appoint an individual as its representative to attend and vote at the meeting and exercise any other powers the company member can exercise at the meeting. Where the company has a sole Director who is also the sole Company Secretary, this form must be signed by that person. If the company (pursuant to section 204A of the Corporations Act 2001) does not have a Company Secretary, a Sole Director can also sign alone. Otherwise this form must be signed by a Director jointly with either another Director or a Company Secretary. Please indicate the office held by signing in the appropriate place.

Lodgment of a Voting/Proxy Form

If you intend to vote on the resolution by proxy, for your appointment of a proxy to be valid, the Proxy Form must be received by Credit Union SA Ltd by 5.30pm on Monday 11 November 2024. You can lodge your Proxy Form:
