2024 Credit Union SA Ltd Annual General Meeting and Director Election

We are holding our 2024 Annual General Meeting (AGM) on 13 November 2024 at 5:30pm. This year's AGM will again be conducted electronically in accordance with the provisions of the *Corporations Act 2001* and the Credit Union SA Ltd constitution. The AGM is an opportunity for members to see and hear directly from our Board of Directors and CEO regarding key information.

This year there are no proposed resolutions and therefore no direct voting is available of the meeting.

Director Election

This year there is only one candidate for election as a Director following determinations made by the Board and taking into account recommendations made by the Nominations Panel. As the number of candidates is equal to the number of positions to be filled (one), an election will not be necessary, and the eligible candidate will be appointed as an elected Director by announcement at the AGM.
