

Credit Union SA “\$5,000 Education Community Giveaway” Terms and Conditions



1. Information on how to take part in the Giveaway and details of the Credit Union SA “\$5,000 Education Community Giveaway” prize are outlined in these terms and conditions. Participation in this Giveaway is deemed acceptance of these terms and conditions.
2. The promoter is Credit Union SA Ltd ("Promoter") ABN 36 087 651 232 AFSL/Australian Credit Licence Number 241066 Credit Union SA Centre, Level 3, 400 King William Street, Adelaide SA 5000.
3. Giveaway entry is only available to current or retired employees of the South Australian community, students carrying out studies in education, and their eligible immediate family (parents, children, grandparents, grandchildren, siblings, and partners only), aged 18 years and older. Employees (and their immediate families) of the Promoter are ineligible to enter the Promotion. Winners will be notified within 7 days of the draw by phone or email to the details listed in their entry form. Credit Union SA will request prize winners to respond via phone call or email to organise collection of their prize. If winner(s) do not respond or the prize is not collected by 12pm (ACST) on 18th of December 2025, a new winner(s) will be drawn at random.
