1. Information on how to take part in the Giveaway and details of the Credit Union SA "FIVEaa Locker Room Experience" Giveaway prize is outlined in these terms and conditions. Participation in this Giveaway is deemed acceptance of these terms and conditions.

3. Giveaway entry is only available to members of Credit Union SA, aged 18 years and older.
