

## Port Adelaide Football Club promotion - Power up your chance to win a MG Terms & conditions

- 3. Promotion is limited to residents of South Australia only, aged 18 years and older that are Port Adelaide Football Club members and Credit Union SA members. Entrants must be a Port Adelaide Football Club member who has an active Home Loan with Credit Union SA at the time of the draw (eligible Port Adelaide members will need to flag with Credit Union SA that they are a Port Adelaide member before the draw has taken place), and Credit Union SA member.
