# How can our school apply for funding?

#### **Application Process**

We have made applying for the School Impact Program quick and easy!

Applications are open from Tuesday, 28 January 2025 and will close on Friday, 4 July 2025. You will find the application form and further information about the program at creditunionsa.com.au/SIP.

The application should take you approximately 15 minutes to complete. We just need to know a little more about your school and what you will use the funds for. We don't require any quotes or invoices.

**Please note** we can only accept applications from school leadership and only one application per school, per year.

We are unable to accept applications from teachers, SSO/ESO, governing councils/ fundraising committees or parents.

Please connect with your school leadership about applying.

#### **Assessment Process**

The application form sets out the key questions that will be used to asses applications, such as how the funds will be used to benefit students or staff, and the potential for collaboration.

Applications will be assessed by a selection panel comprising of Credit Union SA employees and Department for Education executive managers.

**Please note** that the final impact funding amount for successful applicants may be adjusted by the selection panel.
