



## **Credit Union SA “\$5,000 Education Community Giveaway” Terms and Conditions**

Giveaway entry is only available to current or retired employees of the South Australian community, students carrying out studies in education, and their eligible immediate family (parents, children, grandparents, grandchildren, siblings, and partners only), aged 18 years and older.
