1. Information on how to take part in the Giveaway and details of the Credit Union SA “Access Account or Educator + Chance to Win \$1,000” prize are outlined in these terms and conditions. Participation in this Giveaway is deemed acceptance of these terms and conditions.

Giveaway entry is only available to new Credit Union SA members who open an Access Account (subject to eligibility criteria) or an Educator + Account (subject to eligibility criteria), between 7 April 2026 and 31 July 2026. A new member is defined as an individual who does not currently have a RIM / membership number with Credit Union SA prior to the giveaway period mentioned earlier.

Entry to the giveaway is automatic for new Credit Union SA members who open either an Access or Educator + account during the giveaway period. Entry is limited to one per member regardless of how many Access or Educator + accounts are opened by that person. Entry is not available to current Credit Union SA employees, and all entrants must be over 18 years of age.
