

**Credit Union SA “Up to \$200 Cashback for 2027 Port Adelaide Football Club Members”
Terms and Conditions**

1. Information on how to participate in the Credit Union SA “Up to \$200 Cashback for 2027 Port Adelaide Football Club Members” promotion (Promotion), including eligibility requirements and cashback payment details, is set out in these terms and conditions. Participation in the Promotion is deemed acceptance of these terms and conditions.
2. The promoter is Credit Union SA Ltd ("Promoter") ABN 36 087 651 232 AFSL/Australian Credit Licence Number 241066 Credit Union SA Centre, Level 3, 400 King William Street, Adelaide SA 5000.
3. The Promotion is open to South Australian residents aged 18 years or over who, during the Promotional Period, satisfy all eligibility requirements in these terms and conditions, including opening a new Credit Union SA Port+ Account and redeeming or holding a 2027 Port Adelaide Football Club Membership with a minimum annual spend of \$275.
4. The Promotion will run from 12:00pm ACST on Monday, 14 September 2026 to 12:00pm Adelaide time on Thursday, 31 December 2026 (Promotional Period).
5. To be eligible to participate in the Promotion, an entrant must, during the Promotional Period:
 - a) open a new Credit Union SA Port+ Account, subject to the applicable product eligibility criteria, and
 - b) redeem or hold a 2027 Port Adelaide Football Club Membership with a minimum annual spend of \$275.

Each eligible entrant may receive one (1) cashback entitlement only, regardless of the number of Port+ Accounts opened or 2027 Port Adelaide Football Club Memberships held. Joint accounts will be treated as one (1) entry.

A 2027 Port Adelaide Football Club Membership may be redeemed or held by:

- a) payment in full of the annual membership fee, or
- b) commencing instalment payments using the participant's Port+ Account, with at least one instalment processed before the end of the Promotional Period. The instalment payment has no minimum value, provided the membership has a minimum annual spend of \$275.

Eligibility is subject to verification by the Promoter, including verification of the participant's 2027 Port Adelaide Football Club membership where required.

6. The total cashback prize pool for the Promotion is \$20,000.

Up to \$200 cashback is available to the first 100 eligible entrants who satisfy all applicable eligibility requirements during the Promotional Period. Eligible entrants will be determined in chronological order based on the date and time their new Port+ Account is opened, subject to verification of all eligibility requirements. One cashback entitlement is available per person.

Subject to meeting the eligibility requirements in these terms and conditions, eligible participants may receive up to \$200 cashback, comprising two (2) cashback payments of \$100 each, to be paid as follows:

1. the first \$100 cashback payment will be paid on Wednesday, 10 March 2027, and
2. the second \$100 cashback payment will be paid on Monday, 30 August 2027. To be eligible for the second cashback payment, participants must have qualified for the first cashback payment and continue to meet the eligibility requirements specified in these terms and conditions at the time the second cashback payment is made.

Cashback payments will be deposited directly into the participant's Port+ Account. Participants must maintain an active Port+ Account at the time each cashback payment is made.

For the purposes of this Promotion, an active Port+ Account means an account that is not dormant, closed or in breach of the applicable account and membership terms and conditions.

The Promoter reserves the right to verify the eligibility of each participant (including their identity, age, and place of residence) and the validity of each member and to determine a person as ineligible, any person who the Promoter has reason to believe has breached any of these terms and conditions, tampered with the process or engaged in any unlawful or other improper misconduct, calculated to jeopardise fair and proper conduct of this Promotion. Further, any contact details provided incorrectly may be deemed by the Promoter as an ineligible participant. Errors and omissions may be accepted at the Promoter's sole discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
8. Employees (and their immediate families) of the Promoter are ineligible to enter the Promotion. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
