

## Credit Union SA – Win a MG (“Promotion”)

1. Information on how to take part in the Promotion and details of the Credit Union SA ‘Win a MG’ Promotion, form part of the conditions of entry and are outlined in these terms and conditions. Participation in the Promotion is deemed acceptance of these terms and conditions.
2. The promoter is Credit Union SA LTD (“Promoter”) ABN 36 087 651 232  
AFSL/Australian Credit Licence Number 2410636 – Credit Union SA Centre, Level 3,400 King William Street, Adelaide SA 5000
3. Promotion is limited to residents of South Australia only, aged 18 years and older that are Credit Union SA members and either Port Adelaide Football club members or Port Adelaide Football Club employees. Entrants must be a Port Adelaide Football Club member or Port Adelaide Football Club employee who has an active Home Loan with Credit Union SA at the time of the draw and Credit Union SA member. (eligible Port Adelaide Football Club members and Port Adelaide Football Club employees will need to flag with Credit Union about their membership or employee status before the draw has taken place)
4. All Credit Union SA members with an active home loan who have flagged their Port Adelaide Membership or Employee status with Credit Union SA will be entered automatically into the draw at the end of the trade promotion period.

Each eligible member (primary owner of home loan and joint owners) will be entered into the draw once per Credit Union SA membership, regardless of the numbers of loans they have with Credit Union SA.

5. Employees and third-party referrers (i.e Home Loan Mortgage Brokers, Personal Lending Brokers) and immediate family members of the Promoter, are ineligible to enter the Promotion. If the winner does not respond, please refer to clause 6.1 for unclaimed prize conditions.
