

## Win \$1,000 with our Education + Account Promotion ("Promotion") – Terms & conditions

- 1. Information on how to take part in the Credit Union SA 'Win \$1,000 with our Education + Account' Promotion, form part of conditions of entry and are outlined in these terms and conditions. Participation in this Promotion is deemed acceptance of these terms and conditions.
- 2. The Promotion commences at **8:00am on Thursday 30 May 2024** and closes at **12:00pm on Sunday 8 December 2024** ("Promotion Period"). All references to times recorded throughout these terms and conditions are a reference to local time in Adelaide, South Australia.
- The promoter is Credit Union SA Ltd | ABN 36 087 651 232 | AFSL/Australian Credit Licence 241066 | Credit Union SA Centre, Level 3, 400 King William Street, Adelaide SA 5000 ("Promoter").
- 4. Promotion is limited to residents of South Australian only, aged 18 years and older who are current or new members of Credit Union SA that open or transfer an existing account to the Educator + Account ("Account"). The Account must be active (open) on the date that the draw is conducted. To be eligible entrants must also be:
  - Current or retired employees of the South Australian education community,
  - a student carrying out studies in education, or
  - eligible family members (parents, children, grandparents, grandchildren, siblings, and partners only).

Entrants should consider the terms and conditions before determining whether any of the products issued by the Promoter are suitable to their situation.

- 5. Employees (and their immediate families) of the Promoter, are ineligible to enter the Promotion. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

The winner will be given 5 business days after the Promoter's initial contact to claim their prize. If the winner does not have an active Account or does not claim the prize please refer to clause 8.1 for conditions.

The one (1) \$1,000 cash prize is to be deposited into the winner's Account within 5 business days of the prize being claimed by the winner. The Promoter is not liable and is not obliged to provide an alternative prize in the event that the winner is unable to accept the prize for any reason.

The winner will be posted on the Credit Union SA website (creditunionsa.com.au) within 30 days of initial contact with the winner and will include the initial of their first name and their surname.
